SisterWood is a local Devon charity responding to the need for supporting young women's mental wellbeing. Our aim is to create a foundation of mental wellbeing for young women that provides a toolkit of confidence and resilience so they can handle whatever life brings. SisterWood operates in the Teign Valley with a catchment of Exeter, East Devon and Teignbridge, within a 30-minute commute of our site at Deer Leap Farm, EX6 7QR.

Our programme supports girls and those identifying as female aged 12-16, whose experiences with mental ill health impact their day to day lives. Our sessions will run one day a week from January during the academic term, blending forest school skills and mindfulness-based practices. As our target

beneficiaries come from lower socio-economic and marginalised

backgrounds, we offer fully funded places so that the cost of our programme does not land at the feet of parents / carers who really need the support for

their children. As such, fundraising is a high priority for the team, and though the Director the Trustee team are working hard to bring funds in, we

could do with some additional support!

A willingness to be reliable is key, liaising with the Director and Fundraising Trustee on all activities. Volunteers must be willing to undertake a DBS (background) check and to work within guidelines, always following confidentiality, data protection and safeguarding policies.

Tasks and activities

- Assist Director and Fundraising Trustee with online fundraising activities.
- Promote SisterWood online fundraising platforms such as Just Giving; social media fundraising; website fundraising and more.
- Forge new avenues for online fundraising.
- Assist with finding new trust grants and adding opportunities to the internal database.
- Take part in an induction prior to the beginning of the programme: December 2023 TBC.

In return, as a SisterWood Volunteer, you will have the opportunity to:

- Take part in our SisterWood Community Days and monthly gatherings in the woods, developing positive connections within your community.
- Undertake training on mental wellbeing, safeguarding and working with young people.
- Support young people's healthy social development.
- Be part of a friendly team and a supportive community.

- Feel able to tell us if you are dissatisfied in any way, or if there are improvements we can make.
- Keep to all other SisterWood policies and procedures, summarised in the volunteer handbook and available in full on request or via the website.
